THE CRIMINAL PROCEDURE (APPOINTMENT OF CYBER FORENSIC EXPERTS) NOTICE, 2025

- Citation 1. This Notice may be cited as the Criminal Procedure (Appointment of Cyber Forensic Experts) Notice, 2025
- Appointment of cyber forensic expert 2. A person whose name is specified in the Schedule is appointed to be a cyber forensic expert for the purpose of preparing a report to be used as evidence in any criminal case or related matters pursuant to section 220.
- Tenure of appointment 3.-(1) The appointment shall be for a period of five years from the date of coming into operation of this Notice.
(2) Notwithstanding the provisions of subparagraph (1), the appointment of a person appointed as cyber forensic expert shall cease, if-
- (a) his employment in the public service comes to an end; or
 - (b) his appointment is revoked by the Director of Public Prosecutions.
