THE CRIMINAL PROCEDURE (APPOINTMENT OF PHOTOGRAPHIC EXPERTS) NOTICE, 2025

Citation 1. This Notice may be cited as the Criminal Procedure (Appointment of Photographic Experts) Notice, 2025.

Appointment of photographic expert 2. A person whose name is specified in the Schedule is appointed to be a photographic expert for the purpose of issuing a certificate to be used as evidence in any criminal case or related matters pursuant to section 216.

Tenure of appointment 3.-(1) The appointment shall be for a period of five years from the date of coming into operation of this Notice.
(2) Notwithstanding the provisions of subparagraph (1), the appointment of a photographic expert shall cease if-
(a) his employment in the public service has come to an end; or
(b) his appointment is revoked by the Director of Public Prosecutions.
